

WILDWOOD CEMETERY

General Rules & Regulations

1. The peacefulness of the cemetery shall not be disturbed by noise or improper conduct.
2. Littering is not allowed in any part of the cemetery. Receptacles are provided for garbage.
3. The speed limit on cemetery roads is 15 MPH.
4. Picnics, fires, and dogs are not allowed in the cemetery.
5. Loitering is not allowed on the cemetery grounds after sunset.
6. No advertising or solicitation of any nature will be allowed in the cemetery.
7. Decoration and planting guidelines:
 1. **Beginning May 1st**, spring/summer decorations and flowers may be placed on gravesites. Spring/summer decorations and flowers shall be **removed by October 15th**.
 2. **Beginning November 15th**, fall/winter decorations and flowers may be placed on gravesites. Fall/winter decorations and flowers shall be **removed by April 1st**.
 3. Shrub or tree plantings must be approved by Cemetery personnel.
 4. Flowers can only be planted in front of stones, with the exception of Section 19 which only allows artificial flowers. No tall perennials shall be planted which would block the lettering on the markers. Annuals can be planted on single graves not to exceed the width of the grave or stone.
 5. Boxes, shelves, ornaments, chairs, settees, glass, wood or iron cases, or similar items shall not be placed on the graves.
 6. Please refrain from leaving food items and beverages on the graves as these items may attract rodents or other wild animals.

Note: Cemetery personnel reserve the right to remove any items in violation of the above decoration and planting guidelines.

8. Markers and monuments must be approved by the Cemetery Administration prior to installation. A monument or marker *will not* be placed or erected on lots or graves that have not been paid in full. Monument and marker regulations vary from section to section. Check with the office or a monument dealer before purchasing a monument or marker.
9. Veteran flags can be obtained from the Veterans Office (920-459-3053).
10. Perpetual care of the graves is included in the price of the grave/lot and includes cutting grass at reasonable intervals, raking and cleaning of the grave/lot, pruning of shrubs and trees, and other work as may be necessary to keep the grave/lot in good, neat condition. *Perpetual care does not include the planting of flowers/plants or the cleaning of monuments/markers.* The cemetery *is not* responsible for the repair or replacement of any foundation, marker or monumental structure.
11. A lot owner may, at the time of purchase or at any time thereafter, direct who shall be interred on the lot. Forms are available in the cemetery office. Interment of two bodies in one grave shall not be allowed in cemetery except in cases of mother and infant or twin children. Two interments of cremated remains are allowed in one grave.
